Visit Rwanda Weibo Competition

These terms and conditions ("Terms and Conditions") set out the basis on which you can participate in the *Visit Rwanda Weibo Competition* (the "Competition"). By entering the Competition, you accept these Terms and Conditions in full. If you do not accept these Terms and Conditions, you should not enter the Competition and you will not be eligible to win the prize.

1. **COMPETITION PERIOD:** The start date for entries is 10/04/2019 at 14:00 Beijing time ("**Start Date**"). The closing date for entries is 24/04/2019 at 23:59 Beijing time ("**Closing Date**"). Entries received after the Closing Date will not be entered into the Competition.
2. **TO ENTER:** To enter the Competition, you repost the Arsenal post announcing the competition and tag a friend sharing what you know about Rwanda and your travel ideas. Your post must be shared on Weibo using the #VisitRwanda hashtag no later than the Closing Date.
3. **ELIGIBILITY:** Entry is open to Chinese residents who are 18 years old and over. Only one entry per person is allowed.
4. Employees of The Arsenal Football Club Plc (company number 109244) ("**Arsenal**") or members of their immediate families are not eligible to enter the Competition.
5. No purchase is required to enter but you will require a Weibo account and internet access to enter the Competition. No refund may be claimed for any expenses incurred relating to the use of an email account or internet connection for the purpose of entering the Competition.
6. **PRIZE:** There is one prize available to win, listed below (the "**Prize**").
 - 6.1 One Arsenal home shirt signed by members of the 2018/2019 squad. The Prize is non-transferable and no cash alternative will be offered.

Winners will need to provide contact and address details for the Prize to be sent out.

7. It is the responsibility of the winner to ensure that they provide the correct and full contact details for the prize to be sent out.
8. Arsenal and/or the Promoter reserves the right to substitute the Prize(s) (or any part of it/them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond their control. There is no cash alternative to the Prizes (or any part of them) and unless agreed otherwise in writing the Prizes are non-refundable and non-transferable. All costs and expenses not included within the Prizes are the responsibility of the winner(s).
9. Third party terms and conditions apply to parts of the Prizes where applicable.

10. **SELECTION OF WINNER:** The winner will be picked based on the post that receives the most number of reposts. This will be done by the Promoter from all eligible entries received between the Start Date and the Closing Date. Posts which have been boosted through paid advertising will not be eligible.
11. The winner will be contacted using the contact details provided on entry within 72 hours of the Closing Date. If the winner cannot be contacted or does not respond to confirm details for delivery of the Prize(s) within 14 days, an alternative winner will be selected based on the criteria in Paragraph 10 from the remaining eligible and correct entries.
12. Unless otherwise notified by the Promoter, the Prize(s) will be delivered/confirmed to the winner(s) within 30 days of confirmation of the winners' addresses for delivery of the Prize(s).
13. **PUBLICITY AND PERSONAL DATA:** The winner agrees to take part in reasonable publicity relating to the Competition and Arsenal and/or the Promoter may use the winners' name(s) and image(s) and their comments relating to the Competition and/or the Prize for future promotional, marketing and publicity purposes in any media worldwide without notice and without any fee being paid.
14. Details of the winner's name will be available on request for one month after the Closing Date by writing to the Promoter (including providing a stamped self-addressed envelope and stating the name and closing date of the Competition) at the address set out below.
15. The Promoter will use entrants' personal details for the purposes of administering the Competition and awarding the Prize(s).
16. **OTHER IMPORTANT INFORMATION:** Entries must not be submitted through agents or third parties. No responsibility can be accepted for lost, delayed or incomplete entries, or for electronic entries or winning notifications that are not received or delivered (for any reason including as a consequence of communication or network failures). Any such entries will be deemed void.
17. The Promoter reserves the right to withdraw or amend the Competition or these Terms and Conditions if circumstances outside its reasonable control make this unavoidable.
18. Entries must be strictly in accordance with these Terms and Conditions. Any entry not in strict accordance with these Terms and Conditions will be deemed to be invalid and the Prize(s) will not be awarded in respect of such entry. The Promoter reserves the right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms and Conditions.
19. The Promoter's decision is final in all matters relating to the Competition (including the Prize(s)) and no correspondence will be entered into.
20. Except in respect of death or personal injury resulting from any negligence of Arsenal, to the maximum extent permitted by law, neither Arsenal nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise):
 - i. any loss, damage or injury to you and/or any third party or to any property belonging to you or any third party in connection with the Competition and/or the Prize (including the winner's receipt or use of the same), resulting from any cause whatsoever; or

- ii. any loss of profit, loss of use, loss of opportunity or any indirect, economic or consequential losses whatsoever and howsoever caused.
21. The Competition is not in any way sponsored, endorsed or administered by, or associated with Weibo. You acknowledge that Weibo shall not have any liability to you in connection with the Competition. The Promoter reserves the right to disqualify any entrant posting an entry or a comment to Arsenal and/or the Promoter's Weibo account(s) that are, in the Promoter and/or Arsenal's opinion (as the case may be), inappropriate, offensive or upsetting to other entrants, fans of the Promoter and/or Arsenal (as the case may be) or directly aimed at Arsenal and/or the Promoter, or contrary to applicable law, and to remove any such entry or comment.
22. **GOVERNING LAW AND JURISDICTION:** Please note that these Terms and Conditions are governed by English law. This means that your entry into the Competition and any dispute or claim arising out of or in connection with it will be governed by English law. You and the Promoter both agree that the courts of England and Wales will have non-exclusive jurisdiction in connection with any such dispute or claim.
23. **SPIRIT OF THE COMPETITION:** If you attempt to compromise the integrity or proper operation of the Competition by cheating or committing fraud in any way, the Promoter reserves the right to render your entry invalid, seek damages from you and ban you from participating in any of their future competitions.
